Introduction

This datasheet provides specifications and parts list for the Type H823K relief valve. Refer to the H Series Instruction Manual, D450126T012, for information on how to properly install, maintain and test the Type H823K relief valve.

Product Description

Type H823K relief valves are used for a variety of compressed gases and pressurized liquids in mobile and stationary storage. The valves are typically installed in ASME tanks and Department of Transportation (DOT) cargo tanks (see Figure 1). Contact the factory regarding selection of compatible sealing materials. ASME setpoints and flow capacities are available and all units are provided with serial numbers.
